Nominees must be:

- at least sixteen years of age
- actual communicants
- on the Electoral Roll of this Parish for at least six months

No person shall be nominated unless they have signified their consent to serve, or there is in the opinion of the meeting sufficient evidence thereof. No person shall be nominated if they are disqualified from serving by the Church Representation Rules.

Disqualification (Church Representation Rules Part 7, Rules 63 and 68)

A person shall be disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council, a district church council or any synod under these rules if the person:

- A person is disqualified from being nominated, chosen or elected or from serving as a churchwarden or a member of a parochial church council, a district church council or a joint council if the person is disqualified from being a trustee of a charity (and the disqualification is not subject to a waiver which permits membership of a parochial church council, district church council or joint council).
- 2. A person is disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council, a district church council, a joint council or a deanery synod if the person is included in a barred list (within the meaning of the Safeguarding Vulnerable Groups Act 2006).
- 3. A person is disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council, a district church council, a joint council or a deanery synod if the person has been convicted of an offence mentioned in Schedule 1 to the Children and Young Persons Act 1933 (with that expression being construed in accordance with Rule 71(2) of the Church Representation Rules).
- 4. A person's disqualification under sub-paragraph (3) may be waived by the bishop of the diocese by giving the person notice in writing.
- A person is disqualified from being nominated, chosen or elected or from serving as a member of a parochial church council if the person has been disqualified from holding office under section 10(6) of the Incumbent (Vacation of Benefices) Measure 1977.

Note

In order to confirm that you are eligible to act as a charity trustee, all newly elected PCC members will be required to sign a declaration confirming their eligibility to hold office as a charity trustee eligibility (ie nondisqualification under charity law). Most newly elected PCC members will also be asked to sign a Fit and Proper Person declaration. A copy of these declarations can be found at

www.parishresources.org.uk/pccs/apcms. By confirming that you are eligible for election, you are confirming that you are able to sign these declarations.

Safeguarding

Please be aware that anyone putting themselves forward as a PCC representative, Churchwarden or for a Deanery or Diocesan Synod position, must be willing to undertake safer recruitment processes including the completion of a Confidential Declaration form and an enhanced DBS check if elected. They will also need to undertake the relevant safeguarding training.

For PCC members, Churchwardens or for a Deanery or Diocesan Synod position this means completing two safeguarding training modules as a minimum:

- 1. Basic Awareness
- 2. Foundations (renewal every three years)

Appropriate checks will be carried out after the relevant individual is elected to their post; confirmation of the appointment will only take place after the DBS check has been satisfactorily completed and after all the required safeguarding training is completed.
